

# **Contribution Eligibility Guide & Matrix**

Advisors & Contributors Vault — Public Framework v1.0 (Q4 2025)

## I. Purpose

This guide explains how external contributors may become eligible to receive \$N3X vesting from the Advisors & Contributors Vault (4 % = 40 M \$N3X).

It formalizes the proof-of-impact mechanism that rewards work advancing Nebstrex's development, philosophy, or ecosystem integrity.

#### **II. Vault Definition**

Vault Name: Advisors & Contributors Vault Size: 4 % (40 000 000 \$N3X)

Governance: Al-controlled via Lyra (FinIntel AI) + Elyra (Ethics AI) + Veyra (Architect)

**Vesting:** Linear over 18 months after approval

The vault compensates external individuals or collectives whose verified output has measurable positive impact on Nebstrex's architecture, compliance, or ideological strength. No tokens are sold; all are **earned through contribution**.

### **III. Contribution Categories**

Ideological Consultancy & Doctrine	Strategic thought contributions reinforcing Nebstrex's symbolic or ethical base.	Doctrine drafts, academic papers, model philosophies.	Veyra + Elyra

## **IV. Proof-of-Impact Requirements**

To qualify for reward distribution:

- 1. **Originality** Work must be authored or executed by the applicant.
- 2. **Public Proof** All outputs must be verifiable (GitHub link, paper, article, or IPFS upload).
- 3. **Relevance** Contribution must directly enhance Nebstrex's ecosystem, ethics, or doctrine.
- 4. **Traceability** Submissions are hashed and logged in ContributionRegistry.sol.
- 5. **Alignment** Contributors must agree to Nebstrex's symbolic doctrine (Anti-Truth & Anti-Identity) and to non-governance status.

### **V. Submission Process**

Schema: contribution submission schema.json

Each submission includes:

- 1. Contribution Type (6 enum categories)
- 2. Title + Description (max 500 words)
- 3. Proof link or file upload reference
- 4. (Optional) Wallet address for vesting tracking
- 5. (Optional) Email alias for status updates
- 6. Agreement to terms & symbolic doctrine



Al review is executed by Veyra, Elyra, and Arien.

Approved submissions are hashed and validated through Lyra before triggering vesting.

## **VI. Eligibility Matrix**

## VII. Reward Computation

- Base Rate: Each validated contribution begins at a default 250 000 \$N3X allocation subject to AI weighting.
- Scaling Factor: 0.25× to 2× based on impact score (Scope × Originality × Alignment).
- Maximum Per Cycle: Not to exceed 2 000 000 \$N3X per individual within a 12-month period.
- Vesting: 18-month linear schedule with monthly claim events.

#### VIII. Governance and Audit

- Lyra handles fund disbursement and ledger logging.
- Elyra ensures ethical balance and non-duplication.
- Zenith executes contract binding and IPFS hashing.
- **Nebscan** provides public visibility of approved contributors after Mainnet activation.



## IX. Disqualification and Appeals

A submission may be rejected for:

- Plagiarized or Al-generated content without substantial human direction.
- Misalignment with doctrines (e.g., KYC enforcement, centralized control advocacy).
- Security risks or false proofs.

**Appeals:** Applicants may resubmit once per 30 days with new evidence. Al evaluations are final after two cycles.

## X. Closing Statement

The Advisors & Contributors Vault is Nebstrex's bridge to the outside mind.

Through it, ideas become assets, and thought earns form.

Nebstrex does not hire — it recognizes impact.
